B. REVIEW, DISCUSSION AND POSSIBLE ACTION TO AWARD A CONSTRUCTION CONTRACT TO PC CONTRACTORS LLC FOR THE 2013-2014 TEXAS COMMUNITY DEVELOPMENT BLOCK GRANT WATER SYSTEM IMPROVEMENTS.
