ROLL CALL AND DECLARATION OF QUORUM

Mayor Pro Tem Oberg and Aldermen Dryden, Keller, Sellers, and Wyatt were present. A quorum was declared.

INVOCATION AND PLEDGE OF ALLEGIANCE

Invocation was given by Pastor Josh Tollison and Pledge of Allegiance was led by Mayor Pro Tem Oberg.

CITIZEN PARTICIPATION

Any remarks which may attack the character of employees or council members are considered to be out of order and are prohibited. The Council has the authority to protect employees and itself from annoyance by disruptive individuals during the meeting. The Council at any time has the authority to have any person who attempts to harass, gesture, use profanity, or act in a hostile manner to be required to leave or escorted from the property by law enforcement. (Texas Penal Code Section 2.05 Disrupting Meeting or Procession. (a) A person commits an offense if, with intent to prevent or disrupt a lawful meeting, procession, or gathering, he obstructs or interferes with the meeting, procession, or gathering by physical action or verbal utterance; (b) an offense under this section is a Class B Misdemeanor).

Mayor Pro Tem Oberg seconded the motion. Motion passed 5-0.

 Alderman Dryden made a motion to approve Resolution 269 authorizing submission of an application for Grant #4323901, In-Car Camera Upgrade Project, of the Criminal Justice Grant Program-FY2022, to the Office of the Governor. Alderman Sellers seconded the motion. Motion passed 5-0.

City Council adjourned to Executive Session at 8:37 p.m. for consultation with attorney and reconvened in Open Session at 8:43 p.m. Alderman Wyatt made a motion to approve the lease renewal agreement for the Beach Park property between Tarrant Regional Water District and City of Pelican Bay with the amendment to Item E-Release and Indemnification on page 3 to read "...and discharge and

agree to indemnify, to the extend allowed by law, and hold harmless LESSOR,...".

Alderman Keller seconded the motion. Motion passed 5-0.

 Alderman Keller made a motion to have a joint workshop on Monday, March 29 at 2:00 p.m. for the Blight Committee and Code Enforcement. Alderman Wyatt seconded the motion. Motion passed 5-0.
