MINUTES OF A REGULAR MEETING OF THE GOVERNING BODY OF PELICAN BAY

On the 25th day July, 2022 at 7:00 P.M. the Council of the City of Pelican Bay convened in a Regular Meeting, in the City Hall.

1. CALL MEETING TO ORDER AND ESTABLISH QUORUM

Mayor Olague called the regular meeting to order at 7:00 p.m.

Mayor Olague mentioned the following:

Our House Food Pantry out of Reno, Texas, sponsors the Pelican Bay Food Pantry operated by the Neighborhood Activities Committee so they may receive food from the Tarrant Area Food Bank. Numerous complaints caused Our House Food Pantry to withdraw their sponsorship of the Pelican Bay Food Pantry and the Neighborhood Activities Committee resulting in Tarrant Area Food Bank terminating their contract with Neighborhood Activities Committee.

Police Department building is currently undergoing floor replacement by volunteers of the City.

Plans to fence in the back of City Hall and Police Department with access codes in order to secure City vehicles.

Alderman Gassen made a motion duly seconded by Mayor Pro Tem Dryden to approve the Mayor and City Attorney to negotiate an interlocal agreement with Tarrant County for Sherriff's department patrol services not to exceed \$500,000. Motion passed with a vote of 4-0.

8.e. Consider expenditure of approximately \$2300 in received donations previously allocated for food pantry

Alderman Bender made a motion duly seconded by Alderman Gassen to split the donations already received evenly between Animal Control Services and Fire Protection Services. Motion passed 4-0.

8.f. Approval of Resolution 281 authorizing donations from utility accounts to be distributed between Animal Control Services and Fire Services

Mayor Pro Tem Dryden made a motion duly seconded by Alderman Bender to approve Resolution 281. Motion passed 4-0.
