# MINUTES OF A REGULAR MEETING OF THE GOVERNING BODY OF PELICAN BAY

On the 13th day September, 2022 at 7:00 P.M. the Council of the City of Pelican Bay convened in a Regular Meeting, in the City Hall.

# 1. CALL MEETING TO ORDER AND ESTABLISH QUORUM

Mayor Olague called the meeting to order at 7:06 p.m.

Updates on Police Department

Mayor Olague gave updates on police department repairs that included:

Once the building was leveled, the door frames to two entrances shifted resulting in the need to replace the doors.

The fence around City offices has been completed and secured.

Contact was made with Sherriff Wayburn's office on the agreement with Tarrant County Sherriff's Department for police services and we are getting closer to finalizing the steps for them to take over services.

Floor replacement has been completed in the police department building. City had to hire a contractor to complete the installation as the volunteers who were doing the work returned to previous jobs.

The individuals who had previously volunteered generously purchased vehicles from the City's online auction.

Need to look at adding gutters to buildings.

Alderman Gassen made a motion to approve the contract with Briar-Reno Fire Department. Motion seconded by Mayor-Pro Tem Dryden. Motion passed with a vote of 3-1 with Alderman Crawford against.

B. REVIEW, DISCUSS, AND CONSIDER ACTION ON APPOINTING MEMBERS TO SERVE PLACE 2 AND PLACE 4 OF THE CITY OF PELICAN BAY PLANNING & ZONING COMMISSION FOR THE TERM ENDING JUNE 30, 2024.

Mayor Pro-Tem Dryden made a motion to approve Kristine Harrington to serve in Place 2 and Darrell Contreras to serve in Place 4 of the Planning and Zoning Commission with a term ending June 30, 2024. Motion seconded by Alderman Crawford. Motion passed with a vote of 4-0.

C. OATHS OF OFFICE FOR APPOINTED PLACE 2 AND PLACE 4 PLANNING & ZONING COMMISSION MEMBERS.

Mayor Olague gave the Oaths of Office to Ms. Kristine Harrington and Mr. Darrell Contreras.
