# MINUTES OF A REGULAR MEETING OF THE GOVERNING BODY OF PELICAN BAY

On the 15th day November, 2022 at 7:00 P.M. the Council of the City of Pelican Bay convened in a Regular Meeting, in the City Hall.

#### CALL MEETING TO ORDER AND ESTABLISH QUORUM

Mayor Olague called the meeting to order at 7:04 p.m.

Alderman Kathy Bender gave the invocation.

### ITEMS OF COMMUNITY INTEREST

Mayor and Council Reports on Items of Community Interest pursuant to Texas Government Code Section 551.0415 the City Council may report on the following items: (1) expression of thanks, congratulations or condolences; (2) information about holiday schedules; (3) recognition of individuals; (4) reminders about upcoming City Council events; (5) information about community events; and (6) announcements involving imminent threat to public health and safety.

- Tarrant County Mayoral Council

Mayor Olague stated she had a meeting with James McClinton with Tarrant County Community Development Program and he encouraged her to join the Mayor's Council so she can be informed on community grants from Tarrant County that will help fund street repairs. The cost to join the consortium would be \$350.00 per year.

Mayor ProTem Dryden made a motion to approve the Consent Agenda. Alderman Bender seconded the motion. Motion passed with a vote of 3-1 with Alderman Crawford abstaining.

#### **ACTION ITEMS**

1. DISCUSS AND CONSIDER APPROVAL OF THE LOW INCOME HOUSING WATER ASSISTANCE PROGRAM AGREEMENT WITH THE CITY OF FORT WORTH NEIGHBORHOOD SERVICES DEPARTMENT THROUGH SEPTEMBER 30, 2023 AND AUTHORIZE THE MAYOR TO EXECUTE THE AGREEMENT.

Alderman Gassen made a motion to approve the agreement. Alderman Bender seconded the motion. Motion passed unanimously with a vote of 4-0.

2. DISCUSS AND CONSIDER AN APPROVAL OF RESOLUTION NO. 288 APPROVING A PURCHASING CARD AGREEMENT WITH UMB BANK FOR A PURCHASING CARD PROGRAM.

Alderman Gassen made a motion to approve the Resolution approving a purchasing card agreement with UMB bank for a purchasing card program. Alderman Bender seconded the motion. Motion passed unanimously with a vote of 4-0.

3. DISCUSS AND CONSIDER APPROVAL OF THE TEXAS UTILITY HELP PROGRAM UTILITY PROVIDER VENDOR AGREEMENT THROUGH DECEMBER 31, 2023 AND AUTHORIZE THE MAYOR TO EXECUTE THE AGREEMENT.

Mayor Pro Tem Dryden made a motion to approve the agreement. Alderman Bender seconded the motion. Motion passed unanimously with a vote of 4-0.

### 4. DISCUSS AND CONSIDER APPROVING AN ADDITIONAL \$7,500 FOR CITY HALL ROOF REPAIR AND \$4,000 FOR POLICE DEPARTMENT ROOF REPAIR.

Alderman Bender made a motion to approve an additional \$7,500 for the City Hall roof to be repaired and the funds to be taken out of the General Fund Building Maintenance and \$4,000 for the police department roof to be repaired to be taken out of the General Fund Police Department Building Maintenance and to amend the budget on those line items by those dollar amounts. Mayor Pro Tem Dryden seconded the motion. Motion passed unanimously with a vote of 4-0.

# 5. DISCUSS AND CONSIDER APPROVING ORDINANCE NO 277 TO AMEND THE BUDGET FOR THE 2021-2022 BUDGET YEAR.

Alderman Gassen made a motion to approve Ordinance No. 277 amending the budget for the 2021-2022 budget year. Alderman Bender seconded the motion. Motion passed unanimously with a vote of 4-0.

# 6. DISCUSS AND CONSIDER AMENDING THE TRAVEL BUDGET IN FY 2022-2023 BY INCREASING LINE ITEM FROM \$2,000 TO \$5,000.

Mayor Pro Tem Dryden made a motion to increase the FY 2022-2023 travel budget from \$2,000 to \$5,000. Alderman Bender seconded the motion. Motion passed unanimously with a vote of 4-0.

## 7. DISCUSS AND TAKE APPROPRIATE ACTION ON DEFINING THE NUMBER OF HOURS DESIGNATING PART TIME STATUS.

Alderman Gassen made a motion to approve designating less than 32 hours per week as part time for the City of Pelican Bay. Alderman Bender seconded the motion. Motion passed unanimously with a vote of 4-0.

### 8. CONSIDER AND TAKE APPROPRIATE ACTION ON ADDING A PART TIME ANIMAL CONTROL/ORDINANCE ENFORCEMENT POSITION.

Alderman Gassen made a motion to approve adding a part time animal control/ordinance enforcement position. Alderman Crawford seconded the motion. Motion passed unanimously with a vote of 4-0.

# 9. DISCUSSION ON THE STATUS OF MAINTENANCE OF CITY HALL AND POLICE DEPARTMENT BUILDINGS.

### 10. DISCUSSION ON TARRANT COUNTY SHERIFF'S DEPARTMENT AND STATE OF PELICAN BAY POLICE DEPARTMENT.
