AN ORDINANCE PROHIBITING ANY PERSON TO HAVE, KEEP, STORE, SELL, OFFER FOR SALE, GIVE AWAY, USE, TRANSPORT, MANUFACTURE, DISCHARGE, IGNITE OR IN ANY MANNER AID, ASSIST OR ABET IN THE DISCHARGING OR IGNITING OF ANY FIREWORKS WITHIN THE CORPORATE LIMITS OF THE TOWN OF PELICAN EAY, TEXAS; DECREEING THAT THE POSSESSION OF ANY FIREWORKS SHALL CONSTITITE PRIMA FACIE EVIDENCE OF AN INTENT TO VIOLATE THE ORDINANCE; PRESCRIBING A SAVING CLAUSE; PROVIDING THAT ANYONE VIOLATING ANY OF THE PROVISIONS OF THIS ORDINANCE SHALL BE GUILTY OF A MISDEMEANOR AND SHALL BE LIABLE TO A FINE AND UPON CONVICTION SHALL BE FINED IN ANY SUM NOT EXCEEDING \$200.00, AND THAT EACH DAY THAT SUCH VIOLATION EXISTS SHALL CONSTITUTE A SEPARATE AND DISTINCT OFFENSE, AND FOR ENFORCE-MENT HEREOF BY INJUNCTION SUIT, AND PROVIDING FOR PUBLICATION AND AN EFFECTIVE DATE.
