

AN ORDINANCE LEVYING TAXES FOR THE YEAR 1982 TO BE ASSESSED ON ALL TAXABLE PROPERTY WITHIN THE CITY LIMITS OF PELICAN BAY, TEXAS.

WHEREAS: All notices required by law prerequisite to the establishment of a tax rate for the City of Pelican Bay have heretofore been published and public hearings held and the budget has been passed, NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PELICAN BAY, TEXAS, THAT THERE SHALL BE AND THERE IS HEREBY LEVIED THE FOLLOWING TAXES ON EACH ONE HUNDRED DOLLARS (\$100.00) OF VALUATION ON ALL TAXABLE PROPERTY WITHIN THE CITY OF PELICAN BAY, TEXAS, TO BE ASSESSED AND COLLECTED BY THE TAX ASSESSOR AND COLLECTOR, TARRANT COUNTY, FOR THE YEAR FOR THE PURPOSES STIPULATED TO WIT:
